BMW & MINI TRADE CLUB R nineT MOTORBIKE PROMOTION TERMS AND CONDITIONS

1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.

2. Entry is only open to Australian businesses that are members of the BMW and Mini Trade Club. Businesses must have a valid Trade Club Membership Number in order to be deemed eligible for entry into this promotion.
